Subject: One year time limitation for submission of claims under Central Transport Subsidy Scheme (TSS), 1971/ Freight Subsidy Scheme (FSS), 2013- clarification regarding.

Sir/ Madam,

The undersigned is directed to refer to this Department's earlier letter no. 11(9)/91-DBA-II dated 04.05.1993 and letter of even no. dated 24.10.2013 on the above mentioned subject and to say that a number of representations have been received from the State Governments/ Associations regarding one year time limitation for submission of claims under Transport Subsidy Scheme (TSS), 1971/ Freight Subsidy Scheme (FSS), 2013. After considering these representations carefully, the Govt. have decided that the order dated 11.09.2013 of this Department, which envisages that the period of one year is to be counted from the beginning of the quarter and not from the end of the quarter may be implemented with prospective effect and any earlier claim submitted under the interpretation of one year period beginning from the end of the quarter may be admitted.
