

## **Minutes of Meeting of Committee for Technical Evaluation for 'Selection of an agency for creative designing, development and maintenance of CIPAM website'**

1. The Committee for Technical Evaluation (the 'Evaluation Committee') met on various occasions for 'Selection of an agency for creative designing, development and maintenance of CIPAM website' in December, 2016 in Udyog Bhawan.
2. The Interested applicants are requested to submit their responses to the "RFQ – Cum - RFP" on Central Public Procurement Portal (<http://eprocure.gov.in>) on or before November 28th , 2016 till 3:00 PM. The following agencies submitted their proposals on the portal:

3. The Committee took note of the Scope of Work given in Section 5 and the Evaluation Criteria given in para 2.6 of RfQ-cum-RfP for 'Selection of an agency for creative designing, development and maintenance of CIPAM website'.
4. After due consideration of records and the pre-qualification criteria, the Evaluation Committee accepted the following six bidders meeting the minimum qualification criteria:
